Share class rename and new share class launch for certain Wells Fargo money market funds

As previously announced, the Institutional Class will be renamed the Premier Class for the Wells Fargo California Municipal Money Market Fund, the Wells Fargo Municipal Money Market Fund, and the Wells Fargo National Tax-Free Money Market Fund on April 1, 2016.

Additionally, the Wells Fargo Money Market Fund will begin offering the Premier Class on April 1, 2016.

Renaming the Institutional Class for retail money market funds

Under new SEC money market fund regulations, which take effect on or before October 14, 2016, institutional investors are restricted to prime and municipal money market funds that transact at their variable market-based net asset value (NAV). Retail prime and municipal money market funds must limit beneficial owners to natural persons (individual investors).

The money market funds in the table below have been designated as retail funds, which means they will continue to maintain a stable NAV and will be open to individual investors only. To help avoid investor confusion, we will rename the Institutional Class to the Premier Class for these retail funds on April 1, 2016.

The funds' other features, including investment minimums, expenses, tickers, and CUSIPs, will stay the same.

Launching the Premier Class for the Money Market Fund

The Wells Fargo Money Market Fund also has been designated as a retail fund. It does not currently offer the Institutional Class, but we will launch the Premier Class for the fund on April 1, 2016. The Money Market Fund Premier Class will have a minimum initial investment of \$10 million, a net expense ratio of 0.20%, and a gross expense ratio of 0.44%.¹
